### **Proposed Traffic Restrictions – West Street, Berwick-upon-Tweed**

I am writing to inform you that Northumberland County Council has received concerns regarding all-day parking on West Street which obstructs access for pedestrians and vehicles navigating through the route.

As a result, a 'Pedestrian & Cycle Zone' is proposed to cover the extents of the cobbled area, which would be denoted by new signage to replace the existing Controlled Parking Zone signs. As part of the proposed restrictions, loading and unloading would be permitted for vehicles between the hours of 5pm-10am every day to assist businesses carrying out deliveries etc. Loading/unloading would be prohibited from 10am-5pm so that pedestrians have priority of the area and in turn improves road safety.

A drawing showing the proposed extents of the new 'Pedestrian & Cycle Zone' is enclosed.

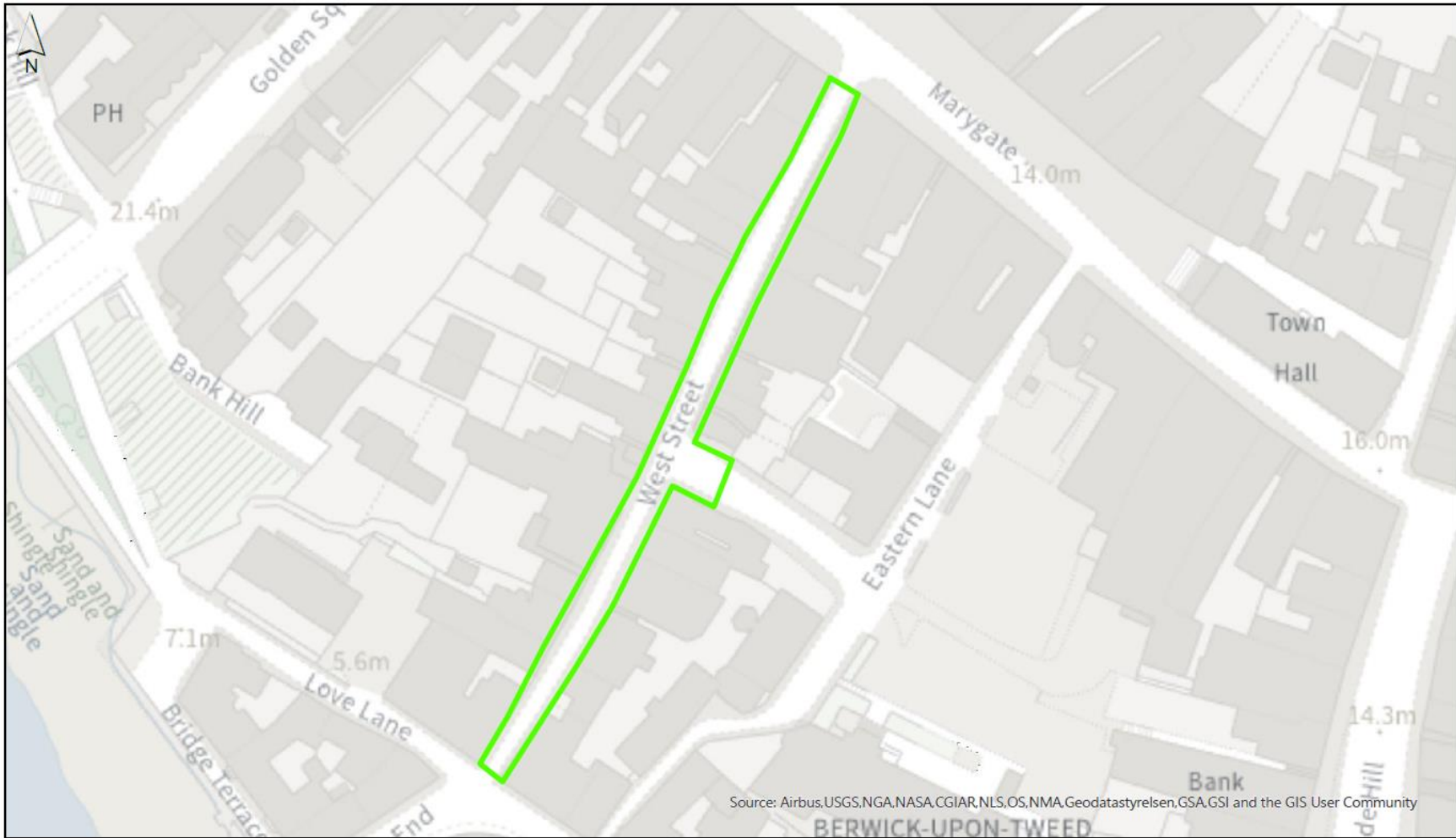
